PARADE WAIVER AND RELEASE

Knowing such risks, participant hereby assumes all those risks and injury to person including death or to property related to event and releases and holds harmless and indemnifies the City of Mathis dba "Freedom Fest" and others for any such injury whether such injury arises from the City of Mathis dba "Freedom Fest" or others' negligence, carelessness, gross negligence or intentional acts, including but not limited to all costs and attorney's fees.

Participant agrees that this waiver and release shall be binding on participants' personal representatives, heirs, assigns and next of kin.
