BOOTH SPACE: 10' x 12'

BOOTH FEE: \$10

ELECTRICITY: We currently are unable to provide electricity to our vendors. You may bring a generator if you require electricity, but it must be kept within your assigned booth space.

SET-UP: Set up begins at 7:00 a.m. Vendors should be prepared for business at 9:00 a.m. or as soon as possible. Spaces not claimed by 8:00 a.m. may be reassigned. Booths must be professional; a canopy is highly recommended. Vendors are expected to stay until 3:00 p.m. All vendors must move their vehicles immediately after unloading. There will be no driving or parking on the McCraw lawn. Loading and unloading must be done from the curb. Bring your dolly.

#### Food Vendors

The Texas Department of Health requires food vendors to obtain permits. A food vendor will not be allowed to set up without the proper permit. Original permits must be displayed in the vendor's space. To inquire about food permits, requirements or exceptions contact the **San Patricio County Health Dept. Food Vendor Permit (361-587-3505)**. **SALES TAX:** All vendors must provide a copy of Texas Sales Tax Permit the day of the event. Exhibitors will be responsible for collecting and paying Texas Sales Tax on all sales made during the show

**CLEANUP:** It is your responsibility to ensure that your area is left clean and orderly. Trash containers are available on site.
